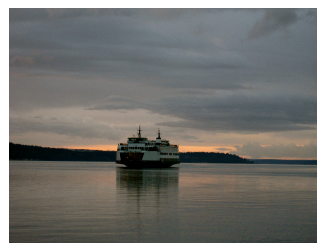

## How Does FWS/WOSA-NA Work?

In February of this year, I was invited to attend the meeting of the FWS (Friends of Woodstock School, Inc.) Board of Directors and Legacy Endowment Fund Drive Committee in Chicago. Dr. Eleanor Nicholson, the new Chair of the Woodstock Board of Directors and Dr. Jonathon Long, the new Principal, were in attendance and contributed enormously to the value and substance of the meetings. The candor and relevance of their comments and observations about Woodstock and the aspirations they hold for the School were both extraordinarily refreshing and encouraging. I am persuaded that Woodstock is in good hands and the mission and vision of the School so widely broadcasted during the past year are realizable -- albeit not without dedication, commitment, and strong support from alumni and friends.

I was also impressed with the competence, knowledge and dedication of individual FWS board members and staff. Everyone takes very seriously their collective responsibilities of soliciting contributions from alumni and friends, prudently managing and investing the proceeds, and carefully assessing grant applications from Woodstock. They constitute as strong a board for non-profit organizations of this size, as one is likely to encounter. Much of the credit goes to Glenn Conrad, President of FWS, for his leadership in recruiting and educating board members and safeguarding the interests of the

donors and supporters while effectively supporting Woodstock.

I would like to highlight a few issues that you may or may not have been aware of or may not have considered their implications.

1. WOSA/NA and FWS have merged into a single entity. WOSA council members form a committee charged with organizing reunions and local events,

2. The principal function of FWS/WOSA-NA as originally constructed, remains that of a non-profit organization authorized under explicit Internal Revenue Service (IRS) codes, to receive contributions and to provide grants, upon review and considerations, to foreign non-profit bodies.

3. Contributions to FWS/WOSA-NA by US taxpayers are tax deductible, provided they do not violate or abuse a set of well-defined - but often overlooked - applicable regulations. The potential penalties for violations are severe -- ranging from FWS losing its non-profit status to revoking tax deductions taken by contributors.

The essence of the applicable IRS regulations is that FWS/WOSA-NA cannot simply be a "conduit" for channeling tax-deductible contributions to Woodstock, which under the IRS codes cannot be a qualified US non-profit organization. The definition of "conduit" means that one may not reach an agreement or an understanding in advance to support Woodstock for any purpose with any Woodstock representative,

and then direct FWS/WOSA-NA to grant your contributions to Woodstock for that purpose. This would be asking FWS/NA to act as a conduit. One may discuss with a FWS/NA representative about how one's contribution may best be used, aside from established programs and projects, but the representative cannot commit to the potential donor's wish, until and unless the FWS/NA Board approves it upon an application submitted by Woodstock for that purpose.

Alternately, FWS/WOSA-NA may unilaterally indicate to Woodstock that it has interests to support certain Woodstock activities, e.g. student scholarship, staff development program and staff housing, but it may not dispense funds or agree to dispense funds to Woodstock without formal action by the FWS/WOSA-NA board. The most common mistake made is to assume that FWS/WOSA-NA and Woodstock is one and the same, or that Woodstock is a qualified non-profit organization under US tax codes. Indeed, IRS codes require FWS/WOSA-NA and Woodstock School maintain a genuine arms-length relationship, notwithstanding FWS/NA's name and that most FWS/WOSA-NA grants benefit Woodstock School.

If you would keep the above in mind, it is easy to contribute to support Woodstock without causing grief to yourself or anyone.
